Thanks for this information. It was what I need for a decision about cooperation.

Your multimedia biofeedback system is an interesting idea and comes very close a real working speech therapist. There are four levels speech recognition and synthesis and video recognition and synthesis (playback). Because of the variability of languages, your program needs an adaption for each language.

A rough calculation shows me, that this project needs at least 500.000 Euro for a basic version with just some main European languages. On the other side we have to see possible customers: speech and language therapists. This group has a small income.

I recommend that you look for some university partners and look also for financial aid from the EU.





After four years studies in University of sofia st kliment oxridsy Bulgaria obtaining several degrees in human communication science in the field of speech therapy, I realised that Bulgaria is not in a position to offer exteneted research facilities in the field, while my ambition is to implement a new approach to speech therapy (articulation) based on the Aristotelian mathematical principles. My basic interest is to find more information in phonology and how the human system works itself. My wish is to follow courses in general linguistics , specializing in experimental phonology. The depth of general linguistics and comparative philology program (ii) for the M/phil program corresponds more closely to my needs. In particular the emphasis of program two on phonetics and phonology would be concentration of value to me. You may find more information in the introduction of my software “logos a new aproach to speech therapy using commonly available computer technology”.
